The projects currently in progress are Alligator Creek East and West, Zipp Family Sports Park, Mission Hill Park, Northwest Park Master Plan, Neighborhood Park Improvements, and System-wide Park Enhancements. The System-wide Parks Master Plan is nearing completion and the Capital Priorities have been identified.

C) Park Ordinance Update

Stephanie Chelar, Recreation Manager, provided an update to the Board on the Ordinance Amendments that were presented during the February meeting.

After additional discussion, Park Staff have removed the addition of Market Plaza from the list of parks allowing alcohol. City events or City partnered events held at Market Plaza would already be exempted from the prohibition with section (c):

(c) The provisions of subsection (a) shall not apply to a city-permitted function where the consumption and possession of intoxicating liquors or alcoholic beverages are permitted as part of the activity.
