Project Summary: Renovation of the overall exterior of the Red Stag building. Many years ago, the original brick façade was plastered over and painted. Over time, the plaster has cracked and been patched and repainted. The current plan is to patch over the entire façade of the building with a smooth stucco that will preserve the exterior of a historic building and renew and improve the visual appeal of the building. New signage will also be applied for the Red Stag business. These improvements will benefit downtown New Braunfels by bringing back to life one of the main corner buildings of downtown and make it more appealing to all the guests downtown.

This proposal covers work that will be completed at the address listed above. We will be applying a skim texture coat in a sand finish to the WORK AREA: front side and left side that runs the length of three of the buildings.

- 1. Awnings and iron work will be removed by others. If in place at the time of service, they will be wrapped and protected.
- 2. Prepare the surfaces on both the front side and the right side which encompasses 3 buildings for the application of a texture sand skim coat, as needed.
- 3. Power wash and prepare buildings for repair and coating, as needed.
- 4. Application of a bonding agent and skim coat.
- Install: scratch coat and finish coat in a sand texture.
- Caulk and seal the cracks around the work areas, as needed.
- 7. Apply a protective coating in 100% elastomeric using a color to be approved by owner.
- 8. Elastomeric coating is a highly flexible coating which when applied correctly by our highly experienced installer helps to bridge hairline cracks, eliminate water intrusion, and control vapor transmission.
- 9. Elastomeric applied correctly is also highly resistant to weathering and sun fade.
- Paint wood trim in a 100% acrylic paint in a like color to that being used on the building.

All work will be performed in a clean workman like manner to promote longevity and a neat appearance. Please allow approximately 21 working days to complete from start to finish, in fair weather as our experience determines.

Total cost of materials and labor for the stucco repairs and exterior coatings described above is \$57,750.00. 33% payment is due for the commencement and 33% with stucco repair complete, 34% final payment when stucco work and painting is complete.

All brands to be used or their application and process will be determined by Diamante Coatings and our experience, unless otherwise specified in this proposal, for estimate and warranty purpose. Water and electricity need to be available, and usage should be considered as part of the cost.

While removing stucco system customers understand that additional underlying damage could be uncovered or cause damage by said removal where underlying issues are unknown, due to original construction beyond our control.

Any underlying damage will be noted and will be added to the completion time of the project and estimate.

All damage caused by the removal of the stucco clad system will not be viewed by the customer as a charge back/or responsibility of Diamante Coatings.

Diamante Coatings can and in most cases repair any additional water Intrusion issues found, within basic wood framing and carpentry. Change order may include additional labor and materials. Thank you,
