- iii. Two corporate hangars are up; third hangar under construction.


On-going Development/Business


- i. Negotiations continuing for a new 14,400 sf corporate hangar.

- v. Customs meeting held 18 July to pursue on-call customs screening.




- i. Kick-off meeting for development & design standards document.
