Mary Irwin asked about the visitation from German tourists; Brittany Hoffmann connects them with local German speakers and mentioned

that opportunities are always expanding and welcomes feedback for more partnership. Fernando Yarrito offered ideas & further opportunities to connect German speaking tourists with local German speakers and the German American Society.
