AN ORDINANCE CHANGING THE NAME OF "VISTA VW" TO "BLUE CLOUD WAY" IN THE SUNSET RIDGE AND VISTA HILLS, UNIT 2 SUBDIVISIONS, CHANGING THE NAME OF "S WATER LN" TO "N GLEAMING TRL" IN THE SUNSET RIDGE SUBDIVISION, CHANGING THE NAME OF "S WATER LN" TO "S GLEAMING TRL" IN THE HIGHLAND GROVE, UNIT 2 SUBDIVISION EFFECTIVE UPON PASSAGE AND APPROVAL OF THIS ORDINANCE.

WHEREAS, it is the intent of the City Council to protect the public health, safety and welfare; and

WHEREAS, municipalities may, under their police powers, enact reasonable regulations to promote the health, safety and welfare of citizens; and

WHEREAS, the City of New Braunfels is a home-rule municipality acting under its Charter adopted by the electorate pursuant to Article 11, Section 5 of the Texas Constitution and Chapter 9 of the Texas Local Government Code; and

WHEREAS, Texas Local Government Code Section 51.001 (1) provides that the governing body of a municipality may adopt, publish, amend, or repeal an ordinance, rule or police regulation that is for the good government, peace, or order of the municipality; and

WHEREAS, Texas Transportation Code Section 311.001 (a) states that a home-rule municipality has exclusive control over and under the public highways, streets, and alleys of the municipality; and

WHEREAS, it is in the public interest to change the name of a public street as set forth herein; **now therefore**:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NEW BRAUNFELS, TEXAS:

SECTION 1

THAT, the street name of Vista Vw be changed to Blue Cloud Way, in the Sunset Ridge and Vista Hills, Unit 2 Subdivisions.

SECTION 2

THAT, the purpose of this street name change is to enhance public safety and streamline emergency response by avoiding potential issues and delays.

SECTION 3

THAT, the street name of S Water Ln be changed to N Gleaming Trl, in the Sunset Ridge Subdivision.

SECTION 4

THAT, the purpose of this street name change is to prevent similar or duplicate street names with the established S Water Ln.

SECTION 5

THAT, the street name of S Water Ln be changed to S Gleaming Trl, in the Highland Grove, Unit 2 Subdivision.

SECTION 6

THAT, the purpose of this street name change is to prevent similar or duplicate street names with the established S Water Ln.

SECTION 7

THAT, the City Manager is hereby ordered and directed to cause City of New Braunfels maps to be amended to reflect the above-described street name change.

SECTION 8

THAT, this ordinance shall take effect upon the second and final reading of same:
