5. TREASURER'S REPORT

Presentation and discussion on the July 2025 Treasurer's Report A) President Hines introduced this item. Jared Werner. Assistant City presented on this matter. Mr. Werner identified 2.6% Manager, increase in sales tax collections for May; with adjustments removed, the current period collections increased by 6.3% compared to May of last year. FY 2025 sales tax collections are up 2.2% compared

FY2024. The increased sales tax collections for May 2025 are tied to increases in the retail. food services, and professional services industries. Mr. Werner shared additional graphs indicating projected commitments current projects. infrastructure to investments. the projected capacity for additional expenditures, the proposed ending fund balance to FY 2027.

6. DISCUSSION AND POSSIBLE ACTION

A) Public hearing, discussion, and possible action approving a Third Amendment to the Contract between the New Braunfels Economic Development Corporation (NBEDC) and HD Supply Facilities Maintenance, Ltd., to modify the percentage of sales taxes rebated and extend the existing contract term, pursuant to Section 501.101 of the Texas Local Government Code.

President Hines introduced this item. Mr. Werner presented a project summary and identified the proposed new contract term and modified sales tax percentage for the Third Amendment.

President Hines opened the public hearing at 5:10PM, no comments were made, and public hearing was closed at 5:10PM. Mr. Werner answered questions from the Board. Nathan Brown, Senior Assistant City Attorney, provided guidance to the Board on proper language to use when making motions.

Director Carden motioned to approve the Third Amendment to the contract, Director Thompson seconded, and the motion was approved unanimously.

B) Public hearing, discussion, and possible action approving an economic development incentive, of up to \$950,000 to Lefko USA, Inc., pursuant to Section 501.101 of the Texas Local Government Code.

President Hines introduced this item. Michele SVP Boggs, New Braunfels Chamber Economic Development, of Commerce. introduced Mr. Eric Blondeau, CEO/President of Lefko USA, Inc. and Hickey & Associates. Mr. Blondeau Ann Miller, and Ms. Hickey presented a brief summary of the proposed project and Ms. Boggs outlined the proposed incentive and compliance metrics.

President Hines opened the public hearing at 5:17PM, no comments were made, and public hearing was closed at 5:17PM.

Director Hurta motioned to approve the incentive to Lefko USA, Inc., Director Meurin seconded, and the motion was approved unanimously.

C) Public hearing, discussion, and possible action approving an additional project expenditure of up to \$3,800,000, to Alamo Colleges District - Northeast Lakeview College for a primary job training facility and career center, pursuant to Sections 501.101 and 501.105 of the Texas Local Government Code

President Hines introduced this item. Jonathan Packer, President & CEO, New Braunfels Chamber of Commerce, discussed the economic impact of this project and introduced Dr. Veronica Garcia, President, Northeast Lakeview College. Dr. Garcia presented a brief summary of the proposed project.

President Hines opened the public hearing at 5:24PM, resident Richard Kelsheimer spoke, Dr. Garcia answered the provided question, and the public hearing was closed at 5:30PM. Jordan Matney, Deputy City Manager answered questions from the Board.

Director Meurin motioned to approve the additional project expenditure to Northeast Lakeview College, Director Hurta seconded, and the motion was approved unanimously.

D) Public hearing, discussion, and possible action approving a project expenditure, of up to \$240,000, to fund the Dry Comal Creek Floodplain Remapping Project, pursuant to Section 505.152 of the Texas Local Government Code.

President Hines introduced this item. Ms. Matney presented a brief summary of the proposed project.

President Hines opened the public hearing at 5:34PM, Richard Kelsheimer, New Braunfels resident spoke, Ms. Matney answered the provided question, and the public hearing was closed at 5:36PM.

Director Carden motioned to approve the project expenditure for the Dry Comal Creek Floodplain remapping project, Director Hurta seconded, and the motion was approved unanimously.



Overview

The Monthly treasurer's report provides updates on sales tax performance, projected revenue streams, projected commitments, and expenditure timing. The NBEDC's financial commitments typically span multiple fiscal years; therefore, the report is formatted to project its financial position over the next five years.

Sales Tax

Compared to June of last year, total sales tax collections increased by 5.3%. When all adjustments are removed, the current period collections increased by 2.8% compared to May of last year. While we are seeing a positive trend in collections in both May and June, we are still projecting flat collections for the remainder of the fiscal year to be conservative. After all adjustments are removed, FY 2025 sales tax collections are up 2.6% compared to FY 2024.







Sales Taxes- The graph and table above reflect the projected sales tax collections through FY 2029. The projections assume a growth of 2.0% annually.

Loan Repayments— The NBEDC began receiving loan repayments from the New Braunfels Regional Airport in FY 2022 (ten years) and ASA properties in FY 2023 (five years with a balloon payment in year six—recognized in FY 2028 above).



BACKGROUND INFORMATION:

The New Braunfels Economic Development Corporation (NBEDC) maintains an annual contract with the City of New Braunfels for administrative support and professional services in support of the NBEDC's mission and business. The contracted amount proposed is \$455,386, which is the same as FY25. Specifically, the contract requires the City to perform administrative and professional service tasks such as contract development and management, pay applications, company and incentive auditing services, fiscal impact analysis, financial auditing, board-directed and required reporting and record keeping. The contract also requires the city to provide for all legal services and facilities needed by the corporation in the normal course of its business. Additionally, the city manages feasibility, engineering, design and construction activities for all NBEDC-initiated projects. Services rendered are provided by a wide array of City departments that include Economic and Community Development, City Attorney's Office, Transportation and Capital Improvements, Planning and Development Services, Finance, and the City Manager's Office.

In 2025, the City received the Texas Comptroller's <u>Transparency Star Award for Economic Development https://newbraunfels.gov/3813/Economic-Development-Transparency-Star. The program recognizes local governments in economic development for going above and beyond in their transparency efforts and that accomplish the following:</u>

- Open their books in the areas of economic development and compliance.
- Provide clear and meaningful financial information by posting financial documents, as well as thorough summaries, visualizations, downloadable data and other relevant information.

The effort requires the City to quantify and report on values of economic development contracts, as well as the status of any active agreements. The City completed contract audits of all companies with active economic development agreements. All NBEDC agreements represent approximately 1,361 full time equivalent employees and approximately \$276 million in ad valorem and business personal property.

Last year, the following modifications were proposed for the FY25 contract: \$50,000 increase earmarked to address operating and property management costs for NBEDC-owned properties and costs associated with additional planning and feasibility studies for future NBEDC-affiliated projects. This will provide some level of pre-approved funding for initiatives not specifically identified but that staff can undertake at the direction of the NBEDC as approved in the services agreement and adopted with the budget. In

Two fiscal years ago, the City presented a contract expansion that fully funded an Assistant Project Manager (APM) in the City's Transportation and Capital Improvements (TCI) department and the marginal cost of moving the ECD's administrative assistant to full-time. These two position additions increased the amount of the contract by \$115,413. Since that time, the TCI department has managed the design and completed construction on three major projects - West Alligator Creek Trail, Common Street Pedestrian Improvements and Last Public Exit Improvement Project - with another (Landa Lake Dam Improvement Project) expected to begin in the fall. The following chart represents all the projects completed, under final design or anticipating construction that the NBEDC has provided funding for (except for the Air Traffic Control Tower, which is funded through an FAA grant but being managed by TCI):



BACKGROUND INFORMATION:

Staff will discuss plans for future workshops and discuss the benefits of a possible strategic planning retreat.

The purpose of a retreat is to help the NBEDC Board gain consensus and prioritize project funding recommendations and other initiatives based on the Confluence Economic Development Plan, as well as the 2024 City Strategic Plan.
