## **RESOLUTION NO. 2023 – R59**

## A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF NEW BRAUNFELS, TEXAS, APPROVING A RECOMMENDATION OF THE NEW BRAUNFELS TAX INCREMENT REINVESTMENT ZONE #3 – DOWNTOWN TIRZ APPROVING THE CREATION OF THE BUSINESS IMPROVEMENT AND PRESERVATION GRANT PROGRAM.

WHEREAS, on September 27, 2021, the New Braunfels City Council approved Ordinance 2021-70 establishing the New Braunfels Tax Increment Reinvestment Zone #3 (Downtown TIRZ) to provide a dedicated funding source and revitalization strategy for the zone; and

WHEREAS, on December 13, 2021, the New Braunfels City Council approved a Resolution 21-R68 adopting the Final Project and Finance Plan for the Downtown TIRZ; and

WHEREAS, in the approved Final Project and Finance Plan, projects are identified as public infrastructure improvements and economic development incentives – both categories are eligible for TIRZ funds; and

WHEREAS, the Downtown TIRZ Board of Directors (TIRZ Board) met on May 11, 2023, to preliminarily discuss the creation of a Downtown Business Improvement & Preservation Grant Program to incentivize downtown improvement projects which fall into the public infrastructure and economic development categories; and

WHEREAS, the TIRZ Board met again on June 8, 2023 and July 13<sup>th</sup>, 2023, to continue discussions on the development of the Downtown Business Improvement & Preservation Grant Program; and

WHEREAS, the TIRZ Board met on August 25<sup>th</sup>, 2023, reviewed, and unanimously approved the final Downtown Business Improvement & Preservation Grant Program Policy Guidelines; and

WHEREAS, an outline of the Downtown Business Improvement & Preservation Grant Program Policy was presented to the New Braunfels City Council at its Special Presentations Meeting on September 18<sup>th</sup>, 2023; and

WHEREAS, all grant applications identified as finalists and recommended for funding by the TIRZ Board will require final approval from the New Braunfels City Council before receiving award letters;

## NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF NEW BRAUNFELS, TEXAS:

<u>SECTION 1:</u> The recommendation of the New Braunfels Tax Increment Reinvestment Zone #3 to create a Downtown Business Improvement & Preservation Grant Program to incentivize Downtown façade & exterior improvements, residential & commercial conversions, and public infrastructure & streetscape projects is hereby approved. SECTION 2: That this Resolution shall become effective from and after the date of its passage.
