

ORDINANCE NO. 2024-__

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF NEW BRAUNFELS, TEXAS, AMENDING CHAPTER 10 AND APPENDIX D “FEE SCHEDULE” OF THE NEW BRAUNFELS CODE OF ORDINANCES; RATIFYING AND ADDING FEES TO APPENDIX D; PROVIDING FOR SEVERABILITY, SAVINGS CLAUSE; REPEALER CLAUSE; AND ESTABLISHING AN EFFECTIVE DATE.

WHEREAS, the City of New Braunfels (“City”) operates the New Braunfels National Airport; and

WHEREAS, the Airport fees and rates are not currently listed in the Fee Schedule in Appendix D of the New Braunfels Code of Ordinances; and

WHEREAS, the City Council of the City of New Braunfels desires to adopt the updates to Appendix D, Fee Schedule, of the City of New Braunfels Code of Ordinances.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NEW BRAUNFELS, TEXAS:

SECTION 1

THAT the findings and recitations set out in the preamble to this Ordinance are found to be true and correct and are hereby adopted by the City Council and made a part hereof for all purposes.

SECTION 2

THAT Chapter 10 of the Code of Ordinances is amended with additions indicated with underlined font and deletions indicated with strikethrough font as follows:

Sec. 10-106. All Other Fees. All fees not incorporated in this chapter are located in Appendix D of this Code.

Secs. 10-107 – 10-120. Reserved.

THAT Appendix D, Fee Schedule, of the City of New Braunfels Code of Ordinances, is hereby amended with additions indicated with underlined font and deletions indicated with strikethrough font as follows:
