c. Reprint Cookbook

Shari obtained a reprint quote from Sundance Printing, which handled the original printing. The cost for 500 copies is \$10,000.01, and for 1,000 copies, the cost is \$20,001.50. The Parks Department is recommending a smaller print run of 250 copies to reduce overall costs. The group would sell the cookbooks at \$38/book. The group voted unanimously to approve the purchase of 250 copies -3^{nd} edition.

d. 2025 Soul Searching

All golf cart sponsorships have been secured and paid for. The artwork for the cart banners has been dropped off at FastSigns to be made. Lynn has been working directly with Sarah in Communications with the City to finalize the program for Soul Searching. The group finalized actors with the need to still locate 2 actors for the Farmer and Louis Meyer. The group is working on scripts for the actors. Jan was able to show several prop items she was able to borrow including cotton sacks and quilts. The group continued to discuss additional props to use for the event – reaching out to Circle Arts Theatre for costumes. Run through will be Sept 30th at Comal Cemetery 6pm to 7pm – food will be provided.
