MINUTES

The New Braunfels Airport Advisory Board met in regular session at 5:30 pm on the 17th day of September 2025.

1. CALL TO ORDER.

The 17 September 2025 Airport Advisory Board Meeting was called to order at 5:30 pm by Wes Stamps.

2. ROLL CALL

A quorum was confirmed with six of seven board members present. Laura Shumaker absent.

7. REPORTS

Airport Director, Dr. Robert Lee presented the Airport Director's Report:

Construction Projects

- i. North Ramp reconstruction is completed.
- ii. Approach end of RY13 and TW-Alpha repairs completed
- iii. Environmental & 30% design for new ATCT.
- iv. Perimeter security fence project started.

On-going Development/Business

- i. KBOX 5 five bay hangar project under design.
- ii. Potential two new hangars.
- iii. H2601 under contract.

Miscellaneous

- i. AMDP in progress.
- ii. Terminal feasibility study: kick off meeting 4 Sept. 2025.

Operations

- Total fuel sales year to date (October August) were 701,110 a 5% increase over last year.
- Year-to-date fuel operations were 5231 versus 5608 last year; decrease primarily due to a flight school that uses mogas instead of 100LL.
- Average monthly Airport operations were 6,563 compared to 6,548 in FY2024.
- Total Airport operations to date were 72,194 compared to 71,580 last fiscal year
- Hangar and facility utilization continues to be 100% occupied.

8. Discussion and Action

A. Discussion and update on the Airport Reception

Kurt Andersen led the discussion for final plans for the Airport Open House. Discussed expected number of attendees, refreshments, and tour of the airfield and Air Traffic Control Tower.

B. Review and Discussion of Airport Reception Presentation

The Airport Director, Dr. Robert Lee, reviewed and explained the reception presentation with the Board. Board was complimentary and expressed their enthusiasm for the upcoming reception.
