Landa Park Golf Course Advisory Board Meeting Minutes {01/14/2025}

- Attendees: Quinton Alexander, Terry Moorehead, Bill Burrell, Austin Milam, Clark Pantel, Mike Graves, and Cas Mikaljczak.
- Called to Order at 6:02 by Bill Burrell
- Minutes from the previous meeting minutes were approved.
  - Motion made by Clark Pantel and Seconded by Austin Milam. Approved without corrections.
- Individual Items for Discussion and Action:
  - Overseed Tee's – Throughout 2024 and now in the monitor phase. Will be gaining member feedback starting that process in October.
  - Resod of Hole #7 – Gold Tees and Red Tees
  - Cart Update – EZ Go – They are shooting for an arrival in April 2025.
  - Beautification – Rock Project – Push back further from the cart path. Goal is to minimize the damage to the carts over time.
  - Winter Storm Prep – Tarps to be delivered the week of 01/14/2025. Plan is to cover the greens at noon on Sunday (19<sup>th</sup>) and keep on until Wednesday.  
Alternative plan will be to "Ice the Greens" – Refer to Quint & Brodie on Process.
  - Upgrading the hitting cases.
  - Painting the on-course restrooms.
  - Fencing area off hole #18 to ensure that trash is not exposed to critters.
  - Dredging the Spring Fed Pool – Will impact hole #2. This will take 1-2 weeks.  
Main impact will be weekday play.

- Tournament and League Update:
  - Normal leagues have continued to max out their capacity giving consistent revenue for the course. {Legends, NBGA and Ladies League}.
- Financial Update for Q4
  - 2024 – 2% Revenue Growth.
  - 2024 – 1% Rounds Played Growth.
    - 49 total days of rain on the course.
  - NBU Project Completion
  - Back Deck Project Completion – Receiving positive responses from players.
    - October – Best October result since 2014
    - November – Revenue up 20%
    - December – Revenue and Rounds were down (12%)
  - Approved for Golf Course Marshalls – Monitor Pace of Play & Course Actions
    - Paid Employees – 2 hires.
      - Presence for enjoyment of the course.
      - Cart Management.
