#### 4. INDIVIDUAL ITEMS FOR CONSIDERATION

A) Presentation and discussion regarding amending the city's ordinance for dangerous dogs.

Animal Welfare Officer Joshua Jimenez gave a presentation on Dangerous Dogs stating the current city code does not meet the current state code. Cases of dangerous dogs have become more frequent and have occurred in this area as well.

The Presentation went over 4 levels of aggressive dogs and what each level of bite would look like. Board members asked clarifying questions. Senior Animal Welfare Office Allison Scheffel-Pratt stated that the aggressive levels would be a type of nuisance level to give the dogs so they can be watched for the nuisance behavior. It would be an option rather than deeming a dog dangerous right away.

Neighborhood Services Manager Bryan Ruiz stated the new verbiage

with the aggressive option would give the animal another chance and be able to remove the aggressive nuisance. Once deemed dangerous they are dangerous for life. Nuisance levels would put them on our radar for close monitoring to prevent from becoming a dangerous dog.

The board stated they needed more information and better defined terms.

B) Presentation and consideration of a recommendation regarding amending the home quarantine procedures.

Currently the victim makes the decision if dog can do home quarantine. The new change would allow Animal Welfare Officers to make that determination based on other factors and the victim would no longer make the decision. This will take the emotion out of the decision by the victim. More home quarantine options would relieve financial pressure on owners and physical space for vets/HSNBA.

Eric Trager, Sarah Hammond, Dr. Ana Robinson, Elizabeth Gooden and Robert Blythin all voted aye and the motion passed unanimously.
