- (A) Z-18-017 Hold a public hearing and consider a request for a variance to Section 3.3-2(b)(1)(v) to allow a proposed home addition to encroach up to 15.4 feet into the 20-foot rear setback in the "R-2" Single and Two-Family District, addressed at 272 Pennsylvania Boulevard.
