### **GENERAL CERTIFICATE**

We, the undersigned, City Secretary of the City of New Braunfels, Texas, and Chief Executive Officer of New Braunfels Utilities, DO HEREBY CERTIFY, with respect to the "City of New Braunfels, Texas, Utility System Revenue Refunding Bonds, Series 2022" dated July 1, 2022 (the "Bonds"), as follows:

Relative to Nonencumbrance. Save and except for the pledge of the income and 1. revenues of the City's Waterworks, Sanitary Sewer and Electric Light and Power Systems to the payment of (i) the principal of and interest to become due with respect to the outstanding (a) "City of New Braunfels, Texas, Utility System Revenue Bonds, Series 2004," dated January 15, 2004, (b) "City of New Braunfels, Texas, Utility System Revenue Bonds, Series 2015." dated January 15, 2015, (c) "City of New Braunfels, Texas, Utility System Revenue and Refunding Bonds, Series 2016," dated March 1, 2016, (d) "City of New Braunfels, Texas, Utility System Revenue Bonds, Series 2018," dated April 1, 2018, (e) "City of New Braunfels, Texas, Utility System Commercial Paper Notes, Series 2019A" and "City of New Braunfels, Texas, Utility System Commercial Paper Notes, Series 2019B" in the maximum principal amount of \$75,000,000, (f) "City of New Braunfels, Texas, Utility System Revenue Refunding Bonds, Series 2020," dated May 1, 2020, (g) "City of New Braunfels, Texas, Utility System Program Notes, Taxable Series 2021" in the maximum principal amount of \$100,000,000, (h) "City of New Braunfels, Texas, Utility System Revenue Refunding Bonds, Series 2021," dated July 1, 2021 (hereinafter collectively referred to as the "Outstanding Obligations") and (i) the proposed Bonds, and (ii) various contracts for the purchase of electric power, said income and revenues of said Systems have not been pledged or hypothecated in any other manner or for any other purpose; and the Outstanding Obligations, the Bonds and the contracts mentioned above evidence the only liens, encumbrances or indebtedness of said Systems or against the income and revenues of such Systems.

### 2. Relative to No-Default.

- (a) The City is not now in default as to any covenant, obligation or agreement contained in any ordinance or other proceeding relating to any obligations of the City payable from and secured by a lien on and pledge of the Net Revenues of the City's Waterworks, Sanitary Sewer and Electric Light and Power Systems, and
- (b) All payments into all special funds or accounts created and established solely for the payment and security of any outstanding obligations payable from and secured by a lien on and pledge of the Net Revenues of the City's Waterworks, Sanitary Sewer and Electric Light and Power Systems have been duly made and the amounts on deposit in such special funds or accounts are the amounts now required to be deposited therein.
- 3. <u>Relative to Utility Properties</u>. The City secures its water from eleven (11) wells and the Guadalupe River and purchases its electric power from various providers. As of the date hereof, no question is pending and no proceedings of any nature have been instituted in any manner questioning the City's right and title to its utility properties or its authority to operate the same.

- 4. <u>Relative to Rates and Charges</u>. The current monthly rates and charges for services provided by the City's Waterworks, Sanitary Sewer and Electric Light and Power Systems are as shown in **Exhibit A**, which is incorporated herein by reference and made a part of this certificate for all purposes.
- 5. <u>Relative to Income and Revenues</u>. The following is a schedule of the gross receipts, operating expenses and net revenues of the City's Waterworks, Sanitary Sewer and Electric Light and Power Systems for the years stated:

The water supply fee is the cost assessed to customers who have a volumetric usage. It consists of the cost of certain water supplies expressed as dollars per thousand gallons, to be multiplied by the gallons sold during a billing period to each customer. Prior to August 1 of each fiscal year, the water supply fee applicable to the months of August-July billing periods is to be calculated based on estimated variables for the period. The amount will be reconciled annually with actual costs and credits. The New Braunfels Utilities Board will be apprised of any changes to the water supply fee.

<sup>\*</sup> A water supply fee for residential is charged for gallons over 7,500. All other rate classes apply to any/all gallons.

#### DETERMINATION OF METERED KW DEMAND

The customer's kW demand may be measured when customer's monthly energy consumption exceeds 3,000 kilowatt hours and/or where customer's total connected load exceeds 25 kilowatts in motors and other inductive-type equipment. Measurement shall be by maximum 15-minute demand. If the customer's demand exceeds 25 kilowatts for any two months during the June through September period, or any four months in a 12-month period, the customer shall be charged for kW billing demand under the appropriate rate class schedule.

#### DETERMINATION OF BILLING KW DEMAND

The billing kW demand shall be the highest measured kW demand established in any 15-minute demand interval during the current month.

#### NET METER SERVICE RATE

The net metering service rate is available in the electric service area of New Braunfels Utilities (NBU) under the rules, regulations, and policies as provided for in this article, at the rates set forth in this section. Service under this rate may be subject to additional connection charges and specifications contained in the NBU Electrical Connection Policy.

The net metering service rate is available to residential customers and small general service customers with grid connected solar or wind generation of ten kilowatts or less where the customer's load profile exceeds the generating capacity.

Service will be provided only by contract approved by the NBU Board of Trustees. Any power generated by the customer may be used to offset the amount of power purchased from NBU. New Braunfels Utilities will not purchase excess generation.
