

Ms. Lovell,

I write in opposition to the proposed rezoning of 1450 FM 1101 from R-2 AH (Single-Family and Two-Family District with Airport Overlay) to R-2 SUP AH (Single-Family and Two-Family District with a Special Use Permit for Multifamily with Airport Overlay).

The reasons for opposition include:

- ➤ The Planning Commission previously heard this issue and the key point of contention by the area residents, specifically the extension of Seminole Drive, and voted to recommend removal of Seminole Drive from the City of New Braunfels Thoroughfare Plan. City staff and City Council have elected to use the Planning Commission's lack of recommendation of an alternative to the extension as justification to ignore the neighboring citizens' requests to remove the extension of Seminole Drive. An alternative to the extension already exists and was approved in the 2019 Bond Election.
- The subject property is already zoned to allow for future development and should be consistent with the adjacent single-family zoning.
- > The City of New Braunfels is requiring the developer to include an extension of Seminole Drive from Alves Lane to FM 1101. This extension will necessarily dramatically increase traffic in the associated Northview area, the addition of multifamily housing will exacerbate that already challenging traffic situation.
- Placement of multifamily housing directly across from the entrance of Canyon High School will jeopardize the safety of those students, parents, faculty, and staff who use the FM 1101 entrances to access Canyon High School.
- A lack of sidewalks and other infrastructure necessary to allow the extension of Seminole Drive to occur safely cannot be imposed on the developer to the degree necessary to address impact to both Seminole Drive and Hueco Drive.

- > Should the city elect to include sidewalks on Seminole Drive and Hueco Drive, the cost of utility improvements would be prohibitive, or unnecessarily burdensome to the New Braunfels Utilities rate payers.
- ➤ In 2018 the City of New Braunfels modified existing code to not allow backing from driveways onto minor collectors. Seminole Drive only serves as a minor collector if it is extended. Up to this point, Seminole Drive has only been a residential collector. City Staff are incorrectly applying the concept of "vesting" which is designed to protect developers and not municipalities. Further, Northview is not a vested subdivision, as the last development in the area occurred over 25 years ago, and current project was only proposed in 2022. See Texas Local Government Code Title 7, Subtitle C, Chapter 245.
- Numerous impacted citizens (see attached) residing in the Northview area previously signed in opposition to any development that would result in an extension of Seminole Drive. As the issue has not changed, reasonably, neither has that opposition.
