RESOLUTION 2024-R

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF NEW BRAUNFELS, TEXAS, APPROVING A RECOMMENDATION OF THE NEW BRAUNFELS ECONOMIC DEVELOPMENT CORPORATION FOR A PROJECT EXPENDITURE OF UP TO \$700,000 TO THE CITY OF NEW BRAUNFELS FOR THE CONSTRUCTION OF COMMON STREET PEDESTRIAN IMPROVEMENTS, A PROJECT AUTHORIZED UNDER 501.103 OF THE TEXAS LOCAL GOVERNMENT CODE.

WHEREAS, the New Braunfels Economic Development Corporation ("NBEDC") Board of Directors met on February 15, 2024 to consider a request from the City of New Braunfels for up to \$700,000 to construct new sidewalks, curb ramps, driveway approaches, and two protected pedestrian crossings on Common Street from Liberty Avenue to Loop 337; and

WHEREAS, the NBEDC has provided direction to undertake feasibility and design work for a series of eligible improvement projects that have been found by the board of directors to be required or suitable for infrastructure necessary to promote or develop new or expanded business enterprises consistent with Section 501.103 of Texas Local Government Code; and

WHEREAS, the completion of Common Street Pedestrian Improvements is an infrastructure expenditure necessary to promote or develop new or expanded business enterprises; and

WHEREAS, the final design of this project was previously funded by the City and a recent City Alamo Area Metropolitan Planning Organization ("AAMPO") award will fund approximately eighty percent (80%) of the project's anticipated construction costs; and

WHEREAS, the remaining total construction costs including construction phase expenses, administration, and a contingency amount total \$700,000; and

WHEREAS, the NBEDC Board held a public hearing on February 15, 2024 to solicit public comments about the City's funding request; and

WHEREAS, the NBEDC Board of Directors, after discussing the request, voted to approve an expenditure in an amount of up to \$700,000 to the City of New Braunfels to fund the construction of Common Street pedestrian improvements;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE CITY OF NEW BRAUNFELS ECONOMIC DEVELOPMENT CORPORATION:

<u>Section 1:</u> That the recommendation of the New Braunfels Economic Development Corporation to approve a project expenditure of up to \$700,000 to the City of New Braunfels for the project to construct Common Street Pedestrian Improvements is hereby approved.

<u>Section 2:</u> That a contract between the NBEDC and the City will be executed to fulfill the terms and conditions of the project expenditure and the NBEDC President and Secretary are authorized to execute the Agreement.

Section 3: That this Resolution shall become effective from and after the date of its passage.
