A) Continued discussion on the development of a Workforce Housing Trust Fund

Chair Allsup introduced this item and reminded the Board about the creation of two working groups, one targeting the beneficiaries of the trust fund and another targeting the priorities of the fund.

Jeff Jewell, Director of Economic and Community Development, gave an overview of the discussion. Initially, the Board was going to break Wednesday, August 16, 2023 New Braunfels Workforce Housing Advisory Committee Regular Meetin into a third committee to discuss funding, but that topic was decided to be addressed at a later phase. The Board was separated into two groups and provided data and worksheets with the following topics to address collaboratively:

Group 1 - Addressing Fund Beneficiaries - Determine income requirement targets and special populations served, if any.

Group 2 - Choose Top Priorities for HTF Program Development - Homeowner/Rental Programs

Groups worked together collaboratively, discussed ideas and concepts, and prioritized each groups' goals. The expected outcome for the evening was to have presentable concrete concepts on the proposed Housing Trust Fund to present to City Council. Due to time constraints, it was ultimately decided to schedule another WHAC meeting for continued discussion needed by the groups to occur before the joint-meeting with City Council on September 13th, 2023. This follow-up meeting date will be selected after polling the Board for their availability.
