MINUTES OF THE NEW BRAUNFELS CITY COUNCIL REGULAR MEETING OF MONDAY, APRIL 10, 2017

The City Council of the City of New Braunfels, Texas, convened in a Regular Session on April 10, 2017, at 6:00 p.m.

The meeting was called to order by Mayor Casteel in the New Braunfels City Hall Council Chambers at 6:01 p.m. Mayor Pro Tem Peters gave the invocation; and Mayor Casteel led the Pledge of Allegiance and the Salute to the Texas Flag.

B) Discuss and consider possible direction to staff for roadway and drainage improvements to Goodwin Lane at Alligator Creek through a development agreement.

A motion was made by Mayor Pro Tem Peters, seconded by Councilmember García, to approve staff recommendations and begin the process of drafting a development agreement that authorizes the owner of Wasser Ranch Subdivision development to design, construct and finance with City participation for proposed improvements to Goodwin Lane at Alligator Creek. The motion passed unanimously.

C) Discuss and consider approval of a resolution adopting the Economic Development Strategic Plan.

D) Discuss and consider approval of the first reading of an ordinance to restore the speed limit of 30 mph on Fredericksburg Road.

F) Public hearing and first reading of an ordinance amending Section 126-354 of the City of New Braunfels Code of Ordinances to revise Parking by Permit Area B.

Esnaurizar Survey No. 1 Abstract 98, addressed at 253 S. Kowald Lane, from "APD" Agricultural/ Pre-Development and "C-3" Commercial Districts to "Solms Landing" Planned Development (SLPD) District with a Concept Plan.
