RESOLUTION NO. 2019-R

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF NEW BRAUNFELS, TEXAS, RECOMMENDING APPROVAL BY TEXAS DEPARTMENT OF TRANSPORTATION OF THE PROPOSED DESIGN OF TWO GATEWAY MONUMENTS AND APPROVAL OF THE INSTALLATION WITHIN THE OPERATIONAL HIGHWAY RIGHT-OFWAY WITHIN THE CITY LIMITS; AND AUTHORIZING THE CITY MANAGER TO EXECUTE THE RELATED TXDOT GATEWAY MONUMENT INTERLOCAL AGREEMENT AND OTHER RELATED AGREEMENTS NECESSARY TO EFFECTUATE THE FINANCING, DESIGN, INSTALLATION, AND MAINTENANCE OF THE GATEWAY MONUMENTS.

WHEREAS, the City of New Braunfels, Texas, is a home rule municipal corporation of the State of Texas and is authorized by the laws of the State to enter into interlocal agreements as authorized by the Texas Government Code, Chapter 791, Interlocal Cooperation Act; and

WHEREAS, the City is further authorized by state law to construct facilities including monument signs within the city limits and to enter into contracts with respect thereto; and

WHEREAS, in preparation of the 175th Anniversary Celebration of the City of New Braunfels, the City would like to install two gateway monument signs along Interstate 35 within the State's right-of-way; and

WHEREAS, the TXDOT requires an ordinance or resolution by the governing body that describes the City's jurisdiction, approval, funding and maintenance of the gateway monument signs located with the city limits; and

WHEREAS, the City Council hereby approves the design proposals and proposed schedule for commencing and completing project installation in accordance with the descriptions an timeline described in Exhibit A to the resolution.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF NEW BRAUNFELS, TEXAS:

SECTION 1: That the City Council hereby approves the proposed design of two gateway monument signs to be erected along Interstate 35 within the State's operational highway right-of-way as depicted in Exhibit A. The proposed schedule for commencing and completing the project installation is included in Exhibit A. The City Council further requests that the State of Texas approves the attached design proposal for two gateway monument signs, and authorize the installation, maintenance, and continued existence, use, and operation of said gateway monument signs. In addition, the city manager is hereby authorized to execute the Interlocal Agreement with the Texas Department of Transportation on behalf of the City of New Braunfels, Texas. The city manager is further authorized to execute all other related agreements necessary and incidental to the Interlocal Agreement, including agreements with the Greater New Braunfels Chamber of

Commerce for financial responsibility of the design and construction of the two monument signs, among other costs.	o gateway
