The Police Sergeant Examination is open to each Police Detective who have at <u>least</u> two (2) years continuous service in the position of Police Detective immediately prior to the examination date to meet the required minimum of three (3) candidates. If unable to reach the required three (3) candidates after the tenth (10th) day registration period for Police Detective, the Police Sergeant Examination is open to each Police Detective with <u>less</u> than two (2) years continuous service in the position of Police Detective. If unable to reach the required three (3) candidates after the tenth (10th) day registration period for Police Detective with <u>less</u> than two (2) years continuous service in the position of Police Detective, the Police Sergeant Examination is open to each Police Officer who have at least two (2) years continuous service in the position of Police Officer immediately prior to the examination date in accordance with the City of New Braunfels Firefighters and Police Officers Civil Service Commission Rules and Regulations and Local Government Code Chapter 143.

All <u>eligible Police Detective employees with two (2) years of service</u>, desiring to participate in the promotional examination must register in person, at the Human Resources/Civil Service Office **no later than 5:00 p.m., Monday, December 20, 2021.**

IF NEEDED, eligible Police Detective employees with less than two (2) years of service, desiring to participate in the promotional examination must register in person, at the Human Resources/Civil Service Office **no later than 5:00 p.m., Thursday, January 6, 2022.**

IF NEEDED, eligible Police Officer employees with two (2) years of service, desiring to participate in the promotional examination must register in person, at the Human Resources/Civil Service Office **no later than 5:00 p.m., Thursday, January 20, 2022.**
