MINUTES OF THE NEW BRAUNFELS CITY COUNCIL REGULAR MEETING OF MONDAY, JULY 24, 2017

The City Council of the City of New Braunfels, Texas, convened in a Regular Session on July 24, 2017, at 6:00 p.m.

- J) Approval of the first reading of an ordinance repealing portions of the Code of Ordinances, Chapter 138, Article I - Vehicles for Hire, to comply with new state legislation that regulates transportation network companies.

measures identified in the Dry Comal Creek/ Comal River Watershed Protection Plan and authorizing the City Manager to accept funds and to execute all contract documents associated with the grant, if awarded.

County Line Road between North Ranch Estates Boulevard and Cornerstone Drive.
