

CITY OF NEW BRAUNFELS RIVER ADVISORY COMMITTEE MEETING September 16, 2021 MINUTES

Thursday, September 16, 2021 at 4:00 p.m.

1. CALL TO ORDER

Parking revenue was good even with two parking lots closed. The River Management fees collected were also high despite the rain we had this summer. Mill Street collected \$30,000 with only 14 parking spaces.

5. DISCUSS 2021 PUBLIC INPUT MEETING QUESTIONS

The committee talked about conducting a survey over having a public input meeting. One question they are considering is security, to include the usage of cameras. In addition, they could ask citizens their awareness of river marker signs and if they know how to help themselves while on the river.

Ms. Niles asked the committee to think about what information they want to gather from the survey and what they want to gain from the survey. This discussion evolved into the possibility of a "did you know" campaign to gauge awareness on the river. The public meeting input is tabled, and the committee is looking to make this a fun facts, helpful, informational campaign to educate the visitors on the river leading up to the next river season.

6. DISCUSS UPDATE ON THE UPCOMING DOS RIOS WATERSHED CLEANUP

Ms. Niles announced that the Dos Rios will be on Saturday, October 2nd. This year it will be conducted a little bit different in that it will be a drive-thru where participants will sign in, get their equipment, clean-up location, a Chick-fil-A lunch and gift.
