## **B.** Field of Graves

Texas State Archeology has identified 5 gravesites and 2 areas of archeological interest. One of the two areas of interest was determined to be a prehistoric (native American) fire pit with stone tools and the second area contained a high concentration of porcelain, glass and

ceramic pieces which appear to be quite old. Brenadette Faust with TCI met with Texas State and on a trial, extended an area towards south Grape Ave. The idea was to hopefully find an area without activity to allow an option to reorient the design. Unfortunately, more graves were found, and this exploration was stopped. Texas State will provide a full report and map with GPS data as part of their final report. Brenadette will continue to keep the committee updated.

### C. 2024 Soul Searching Event

This year's theme will be "Women". The group is continuing to discuss possible actors to portray the souls and deciding the best route to take through the cemetery, adding gaps in tours where needed.
