#### 5. PRESENTATIONS

A) Presentation on the proposed City of New Braunfels Street Design Guide *Mary Hamann, Engineer*

A) Discuss and consider recommendation to City Council to restrict parking on the east side of Hudson Lane from Hanz Drive to Bellesop Boulevard and on the north side of Bellesop Boulevard.

Jessica Perry, Graduate Engineer

Ms. Perry explained the request to restrict parking on east side of Hudson Lane from Hanz Drive to Bellesop Blvd. and on the north side of Bellesop Blvd. After a few minutes of discussion and Glen Levery, a resident and also HOA president, said all the residents are in favor of this item. Mr. Brinkkoeter made a motion to go with staff recommendation. Mr. Yoder seconded the motion. All in favor. Motion passed.

B) Discuss and consider a recommendation to City Council to amend Section 126-346 to establish no parking zones in Prince Solms Park.

Mary Hamann, Engineer

Ms. Hamann explained this item and showed why this recommendation is needed. Mr. Yoder made motion to go with staff recommendation of no parking 1) both sides of Liebscher Drive from intersection with S. Liberty to the beginning of the paid parking spaces on both sides of Liebscher Drive. 2) On South side of the Prince Solms Park parking lot and 3) along the southwest side of Liebscher Drive from the 1-minute parking loading / unloading zone to the entrance to Prince Solms Parking Lot. Mr. Munyan seconded the motion. All in favor. Motion passed.
