APPROVAL OF MINUTES

Consider approving the minutes of regular meeting of September 14th, 2021.

Jason Vreeland made a motion to approve the minutes; Thomas Blagg seconded the motion which passed unanimously.

CITIZENS' COMMUNICATIONS

PRESENTATIONS

A. Landa Lake Dam Structure Update

• Mark Enders, Watershed Program Manager presented the TCEQ Dam Safety Program with the focus being on the Landa Park Lake Dam. The purpose is to improve the dam while making it TCEQ Adequate.

B. River Update

• David Davenport provided the Board with the 2021 End of Season River Report on the behalf of Amy Niles. The river had an increase in first-time guest, crowds were well behaved, and although we were limited on staff, Tube Chute lifeguards had less saves and assists in comparison to previous years. Parking revenue was up from 2020 and compliance with the disposable container ordinance was well received. Litter numbers were higher due to the first-time guest, but litter found by scuba has continued to decrease.

C. Das Rec Update

• Stephanie Chelar, Das Rec Manager provided a Das Rec update regarding membership data, FY 2021-22 budget, and explained how we achieved close to 100% cost recovery in FY21. Das Rec was closed for three days due to maintenance which allowed for cleaning of the facility, refinished wood floors, and a mural in Kinder Care that pays tribute to Landa Park. Fall programming is currently in full swing with programs and youth leagues.

D. Park Projects Update

- **Pickleball Court Striping:** Staff will stripe pickleball courts on the Hoffman Park (1) and Eikel Park (2) basketball courts to provide additional opportunities for outdoor play.
- Comal River Improvements: Staff met with Freese and Nichols on Monday, October 11 to discuss next steps on the project. A report will be made at the November Park Board meeting with information on next steps for the project.
- Alligator Creek Trail Master Plan Update: A public open house was held on Sept. 15 at the NBU Service Center. An online community questionnaire was posted following the meeting. The residents that attended the open house (24) were able to view maps of the study area, review proposed trail alignment, and consider park and trail amenities. The online community survey presented the same maps and the





linear park and trail as well as other recommendations. All the materials from the public meeting are on the project webpage. A draft report will be completed at the end of the month and presented to the steering committee for review.

- **Dry Comal Trail Update:** No update.
- **Mission Hill Park Update:** Revised drainage plans have been submitted to TCEQ. TCEQ has a 30 minimum and 90 day max to review the plans. The THC report has reviewed with no issues noted. Tentatively, bidding is planned for mid-October.
- **Cypress Bend Restroom Update:** The Environmental Constraints Report has been completed. The engineering team is now refining their proposed recommendations/options based on that report.
- Elizabeth Street Parking Project: Water quality pond is under construction and moving forward. They are targeting a mid-November (after Wurstfest) for roadway reopening and December 2021 for final completion. New Braunfels street department has paved the first coat of a temporary walkway to be used during Wurstfest and contractor has done a lift of base material.
- NBU Sewer Line Replacement (Hinman Island Dr): Contractor is completing final landscape items and revegetation. Related to this project is the NBU 24' water line replacement. Contractors continue to work on receiving pit on golf course after the first of the year.
- **Sports Complex Update:** The Design Team submitted a 90% plan set for review and permitting. Bidding is tentatively scheduled for January 2022. Staff is refining the Operations and Maintenance Plan and beginning to develop a list of FF&E that is needed for the opening of the facility.

DISCUSSION AND ACTION

• In preparation for the seating of a Bond Advisory Committee to support a proposed 2023 Bond Election, we are requesting the Parks and Recreation Advisory Board to select one member for appointment to the Bond Advisory Committee.

Katie Rae Preston nominated Joe Turner following a second from Thomas Blagg, which passed unanimously.

SUBJECT:

Park Development Update

DISCUSSION:

The City of New Braunfels entered into a Development Agreements with the Arroyo Verde Development. This agreement included:

- 1. The Developer shall construct a private park and public Hike and Bike trail to the specification of the City, and to dedicate 15.69-acre park land (identified in Unit 4, Lots 900, 901, and 902) to the City of New Braunfels.
- 2. The City accepts private park land dedication of 1.70 acres to meet Park Land Ordinance requirements.
- 3. The City accepts the three (3) private park elements instead of four (4) to meet Park Land Ordinance requirements.
- 4. The developer will construct 10-foot wide concrete hike and bike trail to west of Alligator Creek and with a four (4) foot wide sidewalk connection from Arroyo Dorado.
- 5. Upon completion, approval and acceptance of the public Hike and Bike Trail Improvements and park land, the City will reimburse Developer for a portion of the costs of the Hike and Bike Trail Improvements incurred by the Developer, in amount not to exceed \$35,000. The estimated cost of trail construction with sidewalk connection is \$103,475.
- 6. Ownership and Maintenance of Lots 900 and 902 in Unit 4. The City of New Braunfels will own and maintain the 15.69 acres. Operations and Maintenance for the 15.69-acre park land and the Hike and Bike Trail Improvements will conform to the City's best standards and practices as set forth in the Park Maintenance Plan.
- 7. Within 15 days after acceptance by the New Braunfels Park Foundation and the City, the Developer will provide and obtain a two-year warranty for workmanship for benefit of the City and provide the City a one year transferable warranty from all manufacturers for the warrantable equipment in the Developer Installed Hike and Bike Trail Improvements.


The Developer has met their obligations and is ready to dedicate the land for the New Braunfels Parks Foundation (NBPF) who will hold the land in trust for the City. This will allow the value of the land to be used as a grant match if needed. The NBPF will sign a Memorandum of Understanding with the City regarding dedication of the land.



DISCUSSION:

1. **Comal River Improvements**

Staff met with Freese & Nichols on Monday, October 11 to discuss next steps on the project. An internal staff team will be meeting in December to re-group on the project and finalize the project scope.

2. Alligator Creek Trail Master Plan Update

A draft schematic design has been submitted to staff for review and will be provided to the steering committee for final review at the next committee meeting in preparation for a public meeting. The meeting will be held on Wed., November 18 at 6PM, location TBD.

3. **Dry Comal Trail Update**

City is securing rights-of-entry in Segment 1 in order for the consultant to begin surveying later this month. Design process has paused to allow for completion of various NBU projects in and along Segment 1 (Town Creek).

4. Mission Hill Park Update

Texas Commission on Environmental Quality (TCEQ) comments were received 10/15 and the adjusted WPAP was resubmitted to them on 10/22. The design team is updating the construction documents to address remaining permit comments in anticipation of TCEQ's approval of the WPAP. Staff anticipates having the revised plans the week of November 8th. We are drafting the bid documents with the intent of issuing the solicitation within a week of receiving approval from TCEQ. Clearance was received from the Texas Historic Commission (THC).

5. **Elizabeth Street Parking Project**

The parking lot is partially complete and in use for Wurstfest. Following the festival, construction will resume to finish out paying and punch list items. It is anticipated the street and parking lot will open the first of the year. Paving will be restricted due to weather since it is necessary to be 55 degrees and rising to pave.

6. **NBU Sewer Line Replacement - Hinman Island Drive**

Contractor is completing final landscape items and revegetation.

Related to this project is the NBU 24" water line replacement. Contractors continue to work on receiving pit on golf course and anticipate temporary stopping work during Wurstfest. Project looks to be complete on the Golf course after the first of the year.

7. **McQueeney Water Line**

A 24" water line is being installed from County Line road to McQueeney road through Fischer Park. Currently the water line has been installed through the Park, however the contractor will be working to revegetate the area and clean up all trench debris. This project will eventually tie into the Castell waterline project.

8. **Sports Complex Update**

90% construction documents have been submitted for review. Comments will be received in 30 days. Bidding is tentatively scheduled for January 2022.

Staff is refining the Operations and Maintenance Plan and beginning to develop a list of FF&E that is needed for the opening of the facility.
