(2) A registered design professional with engineering experience. (3) A registered mechanical contractor. (4) A registered electrical contractor. (5) A registered plumbing contractor. (6) Two registered general contractors. (7) Or the city council may appoint one person who is an attorney or a citizen of the city, in lieu of any of the previously listed qualified persons. (8) Or the council may appoint an interim board with the persons of qualification determined by the council. Currently, there are unexpired vacancies in the Registered Plumbing Contractor category and the Registered Electrical Contractor professions.

The City Secretary's Office accepted applications until September 30, 2021 and received a total of 7 applications. The Ad Hoc Committee reviewed applications and recommended that the City Council consider the appointments of Dean Rutherford and Jacob Tschoepe.
