BACKGROUND INFORMATION:

A presentation regarding proposed fee adjustments was given at the July Council Retreat. At the retreat, staff was given direction to move forward with implementation of the proposed fee adjustments including changes to Development Fees related to Traffic Impact Analysis Services fees. These fees have never been adjusted. With the traffic impact of new developments being a City priority and community concern, it is important that these reviews occur in a timely manner, which requires the use of third party reviewers. The current fee structure does not come close to covering the costs of the third party reviews. The majority of these proposed fee adjustments will pass through the City's cost to the developer which was the direction that Council gave at the July retreat. This will bring the fees more in line with benchmark cities and help cover the City's costs, which are significant.

These fee adjustments will impact developers.

Council approved the first reading of this item unanimously at the December 11, 2023 meeting.

If approved, a campaign to communicate the changes to the public will take place from January to March 2024, with the planned implementation date of April 1, 2024.
